

Accordingly the company has recognised Provision for income tax and remeasured its deferred tax asset and liabilities based on the rates prescribed in said section. The full impact of this change has been recognised in the statement of Profit and loss. However the final decision for exercising the option permitted under section 115BAA of the Income Tax Act, 1961 will be finalised at the time of filing the Income tax return for the financial year ending on March 31, 2022.

4. The Company has identified Bulk drug and Chemicals as its only primary reportable segment in accordance with the requirements of Ind AS 108, 'Operating Segments'. Accordingly, no-separate segment information has been provided.



1.
